The Great Eastern Trail and the MST

For several years now MSTA has partnered with other like-minded groups in nine Eastern states to create America's newest long-distance footpath. Great Eastern Trail (GET) provides a premier hiking experience on a series of existing trails that are linked or linking to each



other, stretching from Alabama to the Finger Lakes region of New York. This path will ultimately be 2800 km long, crossing New York, Pennsylvania, Maryland, West Virginia,

Virginia, Kentucky, Tennessee, Georgia, and Alabama. The north end is a junction with Finger Lakes Trail at Moss Hill shelter near South Bradford, NY. Eventually, GET will cross south Alabama to reach the Florida border and a junction with Florida National Scenic Trail.

Planner Benton MacKaye's original vision for an Appalachian Trail in the 1920's showed a network of braided trails running the length of the Appalachian Mountains. In 2000 Lloyd MacAskill of PATC published an article in the Appalachian Trailway News calling



attention to the existing trails to the west of the AT and saying "Don't look now, but parts are already in place." This article and a follow-up letter to the editor by Peter Fleszar inspired MST and Finger Lakes Trail conference to take up Tom Thwaites's idea from the late 1980's and establish the MST-FLT connection as one of these linkages

The work on GET, as it has been for MST, is being led by volunteers. The organizational scheme will involve existing volunteer trail clubs, augmented where necessary by new volunteer groups. Volunteers work closely with governmental entities, but the emphasis will be on volunteer leadership. GET will be primarily a hiking trail and its support comes from hiking trail clubs. MSTA provides one of the Board members (currently Peter Fleszar), and the 2011 Board meeting was hosted by MSTA with the amazingly gracious assistance of Woolrich, Inc. in Woolrich, PA.

Each of the trails retains its own blazing standards and its own relationships with landowners and public land managers. At the NY border, the northbound GET hiker changes from the orange blazes of MST to the orange blazes of Crystal Hills Trail, a new branch of Finger Lakes Trail passing through the hills of Steuben County around the "Crystal City" of Corning. In southern PA and MD, GET bifurcates into co-equal routes - the west route uses sections 1-8 of MST along Tussev Mountain to reach a new white blazed Great Eastern Trail connection in Green Ridge State Forest near Flintstone, MD, and the east route uses the yellow, blue, and partially non-blazed Greenwood Spur of MST to reach Standing Stone Trail at Greenwood Furnace State Park, thence orange blazed SST to Cowans Gap State Park to follow blue-blazed (formerly orange) Tuscarora Trail south across the Potomac River to northern Virginia.

Variously blazed and non-blazed routes in and near George Washington

and Jefferson National Forest carry the GET hiker further south to a junction with West Virginia Scenic Trails Association's yellow blazed Allegheny Trail. which meets the Appalachian Trail near the New River at Pearisburg, VA. West from Pearisburg the GET route is under development to Matewan, WV and Elkhorn City, KY where GET turns onto Pine Mountain Trail. Continuing into Tennesee, GET is on the white blazed Cumberland Trail for most of its length, departing for an urban trek through Chattanooga, and crossing into GA on Lookout Mountain within the Chickamauga and Chattanooga National Military Park. Trail workers are seeking connections to the Pinhoti Trail in Georgia and Alabama, with turkey track blazes leading to Flagg Mountain, the southernmost 300+ meter elevation point in the Appalachian Mountain chain. One person we know of has already walked from the FL/AL border as far north as Woolrich on the GET.

The current MST color maps and guides state that MST is "Part of Great Eastern Trail in Pennsylvania," and over the last two years the GET logo has begun to appear at MST trailheads and key points along our route. In 2012, you might begin to hear more about GET as a result of an enhanced partnership with Woolrich, Inc. and Backpacker magazine. Watch this space for more specifics as they are developed.

Tioga Region

The The Dyke Creek relocation is now open, thanks to 2 years of KTA trail workers, and a special trip by Louise Sis to help finish the blazing in August. MST now follows the north part of the Sand Run Falls hiking/ski trail loop to an actual parking area on Arnot Road, and continues north across Fisher Road and Dyke Creek to Tokarz Road at a State Forest boundary where blazes end for now. A new map (thanks to Sheila Kasperek), and new guide to this section are posted to http://www.hike-mst.org/guide.html - as a result of this relocation, 6 km was added to the thru-hiker's MST. We continue our work to locate as much off road trail as possible so we can finally finish blazing the entire MST.

Four times this year, new gas pipelines were built on private land crossing MST that we didn't know about in advance. We have seen that the pipeline crews do move fairly quickly and are skilled at restoring the area, leaving stabilized vegetation and a new viewpoint behind! We know from journals that a couple of thru-hikers this year have had the presence of mind to go around the construction zones. However, the gas companies have not so far been contacting MSTA beforehand. If we know ahead of time, we can take steps to alert hikers and detour them temporarily to a nearby road, surely making all concerned more comfortable. If you are aware of upcoming gas company activity on your land on or near the trail, or you are hiking and encounter a situation related to gas or other construction, please do not hesitate to contact tioga@hike-mst.org or 717 576-3112 (cell).

If you know of a Scout or other youth looking for a service project this year, we have a need for a 300 meter boardwalk to be installed along MST on private land near Route 6. We have the lumber all ready for the right youth to demonstrate their leadership skills through logistics rather than fund raising. A Bridge At The End Of The Tunnel

The ongoing (and ongoing) project to put a safe and accessible bridge over Yellow Creek in the Everett Region is, at this time, tantalizingly within reach. Deb Dunkle, with the support of Pete Fleszar, has put untold time, heroic effort and countless meetings into guiding this project through the labyrinthine intricacies of the grant and permitting process. Although the famous labyrinth of Minos housed only one Minotaur, the team of Dunkle and Fleszar have encountered and overcome obstacles at virtually every turn of this multi-year journey. Fulfilling all the requirements of the various agencies has meant that the meter has continued to run on the cost of the project. At its October meeting the MSTA voted to pledge \$13,000 in order to push the required \$44,700 'match',

needed to release the grant funding, over the threshold with the hope and expectation that this will remove the final hurdle that stands in the way of actually building of the bridge. The MSTA can not thank Deb Dunkle and Pete Fleszar adequately for their tenacity and grit in seeing this complicated project to its conclusion. Donations to help offset this expenditure will be gratefully accepted.
