

Tioga Region Trail Crew spent a lot of hours in the Woolrich Region and completed 2/3 of the excessive list of 25 tasks assembled for the week. Tom Bastian deserves special recognition for working both extra days and second shifts! We took time to honor our newly wed cook and land negotiator, Wanda Shirk, and her proud groom George with a gift basket appropriately wrapped in orange polka dot flagging tape.

The Crew worked across four parcels in Farmington Township, clearing and marking trail past several viewpoints. We tunneled beneath 15 m tall "M.F. rose" with a chain saw and three brushwhackers. A few spot improvements were made for the MST in SGL 37, side hill constructed in Stephenhouse Run, and clearing done on the Keller Trail for the Corps of Engineers.

Thanks to all who turned out for a wonderful job! Nineteen km more MST is now ready to be opened through three townships, except for three gaps within PENNDOT right-of-way. Pete Fleszar

HIKER ALERT SUMMER 2004

Mid State Trail Section 10: The first few hundred meters of trail were rebuilt by the "A team" from the June Trail Care using 6 x 6 s and rebar provided by Tioga State Forest. As you may recall, the part of the trail just north of PA 414 was cut into the face of a cliff by Trail Care in a single day back in 1987. It is a wooded cliff, but still on the steep side. Over the years it has not fared well but has become one of the most heavily used sections of the Mid State Trail. The new improvements make the trail safer and more enjoyable.

The new section of the Mid State at Cowanesque Lake will add a new feature to the longest trail in the state. For about a kilometer the trail follows the old route of PA 49 through the ghost town of Nelson. Nelson was moved to higher ground back in the 1970s when the flood control dam was built. The buildings were removed but the spruce trees along the main road survive and sidewalks can be seen under the heavy growth of brush. At one place a peony bush still competes with this brush. The cross road at the center of town dips gently into the recreational level of Cowanesque lake.

Mid State Trail Association is moving toward renumbering the trail sections whenever the next (11th) edition of the guide book is printed. This may cause some confusion because some trail signs already installed tell the hiker to "see guide sec 2" or "see guide sec 3". Please understand these are the OLD section numbers like the old exit numbers on our interstates. The trail signs in question are made of locust and may last twenty years or more. Renumbering the maps poses other problems if we are to avoid having maps with the same numbers for widely different parts of the trail. Phasing in new map numbers will take about 15 years.

Chuck Keiper Trail: Two relocations to reduce road walking on PA 144 were cut and blazed by the June Trail Care. The first of these runs from the monument to Swamp Branch Road and has a view to the southeast. The portion of the cross connector beyond Swamp Branch Road is still on PA 144. The other relocation is at Drake Hollow and required 1.6 kilometers of side hill construction..

Make the Mid State Trail Yours

Opportunities continue for new overseers for sections of the 430 or so kilometers of the Mid State Trail. It's a wonderful excuse to get out and hike the trail at least three times per year. We will help you if you run into situations you can't handle yourself.

Funding for the MSTA for Trail Protection in the Everett Region

Attention Mid State Trail Association Hikers:

A sum of \$10,755 was deposited in the MSTA account this week. Of this:

\$8,755 is to match the 10.3 acre easement near Everett at \$1000 per acre for undeveloped mountain land and 85% for an easement as opposed to ownership.

Babb Creek Route Progress

Alexandria Road, US Route 22

The open area between US 22 and Alexandria Road at the south end of Section One of the Mid State Trail has been signed "NO PARKING". This area is shown as a parking area on last year's and previous editions of map 201. Hikers should use the large parking lot at the north end of Lower Trail a few hundred meters down Alexandria Road. The reason and authority for this posting are unknown.

Challenge Land Fund Donation

As you know, we recently approved the creation of a land fund to be used for purchasing easements or land outright in order to permanently protect the MST corridor as it passes through private lands. The Susquehanna Appalachian Trail Club, in recognition of our pioneering steps in protecting Pennsylvania footpaths, generously donated \$1,000 to the fund. The value of this fund now stands at over \$13,000.

A generous, anonymous donor has offered to match, dollar-for-dollar, any donations to the land fund made during this calendar year. Please, do what you can to help us build the funds necessary for securing the permanency of the Mid State Trail. Any donations you make this year will be doubled by our generous benefactor. PENNDOT Highway Occupancy Agreement: Illegitimate, Irrational, Possibly Illegal Tom Kelliher

Two years ago, the US Army Corps of Engineers (USACE) asked Pete Fleszar to confirm with PENNDOT that a proposed new section of the Mid State Trail through USACE's Cowanesque Lake lands would not adversely impact PA 49. The USACE is the fee-simple owner of the land, and has granted an easement to PENNDOT for the PA 49 rightof-way. Little did Pete or the USACE know how involved and complicated this seemingly simple request would become.

Prior to Pete's contact PENNDOT had become aware of potential liability issues when a piece of a rail-trail bridge (an old railroad bridge) fell onto a PENNDOT road. PENNDOT then began to develop a Highway Occupancy Agreement (HOA) to be used when footpaths cross PENNDOT roads or otherwise intersect the right-ofway. Unfortunately, the MSTA was chosen as the test case for this new HOA process. DCNR counsel saw an early version of the HOA and were told that it would apply only to rail-trails. We have not found anyone in the footpath community who was consulted or even informed about these new "requirements" before PENNDOT issued a policy memo intended to place these into effect.

Our understanding is that PENNDOT intends to apply the HOA to footpaths as well as all rail-trails. They provide funding to many railtrails, but we don't use their money. The HOA would apply to all crossings, intersections, and road walks, and only the Appalachian Trail would be exempt, because of its special legal status.

We could agree that it might be mutually beneficial for us to have a written understanding with PENNDOT, just as we do with other State agencies. However, the HOA does not benefit the hiking community. There is nothing in it for hikers, not even an obligation for PENNDOT to post signs along the road alerting drivers to hikers crossing the road. Instead, we would be obligated to post signs along the footpath to alert hikers to the road crossing. This would be highly redundant anywhere, and possibly prohibited at Cowanesque by our agreement with the USACE. We don't see how these provisions applied to us even benefit motorists or road maintainers. It is an exercise in bureaucratic unreality gone amok.

The HOA would also require us to provide financial data to PENNDOT, something never requested by any other State agency. Hiking clubs might be required to post a bond, to cover PENNDOT's costs of correcting problems at crossing sites, if the club doesn't correct them itself in a timely manner. We don't know what problems a footpath might cause that would cause financial restitution to be required, or how these non-existent problems relate to the required bonding amounts. Some clubs would be unable to post such a bond. Our certificate of deposit satisfies PENNDOT for now, but what would happen if the HOA was applied to all our road crossings?

PENNDOT thinks of us as a landowner, and requires that we donate land to them if they decide to widen a road. We own no land. Crossing proposals are expected to include detailed engineering plans. The cost of having such plans produced would likely be prohibitive to an organization such as the MSTA.



Finally, we can not find any regulations giving PENNDOT the authority to impose these onerous requirements. The HOA does not cite any legal authority in this matter.

In June, we received the HOA that PENNDOT expects us to sign and are now exploring options. PENNDOT has the Mid State Trail confused with a rail-trail or a public utility. Pete worked with PENNDOT for two years, trying to educate them about the difference between a rail-trail and a footpath. Tom Kelliher, Hugh Downing, and KTA council met with a PENNDOT representative to discuss the issue, too. Although many HOA provisions initially suggested were eliminated in the final draft, all these aforementioned problems remain. All who have seen the final HOA are shocked. Signing it would set a bad precedent for the entire hiking community and lead, I am afraid, to severing numerous footpaths.
